CITY OF HAMILTON

BY-LAW NO. 09-242

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"John	West	Burlington to the extended north curb line of the northern intersection with Murray	Anytime
Villa	West	Anna Capri to 36.1m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"John	West	Burlington to Picton	Anytime
John	West	Simcoe to the extended north curb line of the north intersection with Murray	Anytime
Villa	West	Anna Capri to 21m southerly	Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Tuxedo	West	from 88.7m north of Dunsmure to 9.3m northerly	Anytime"
---------	------	---	----------

and by adding to Section "E" thereof the following item, namely:

"Barnesdale	West	from 65.9m south of Dunsmure to 4.5m southerly	Anytime"
-------------	------	---	----------

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"John	West	Simcoe to Picton	Anytime
Simcoe	North	John to Hughson	7:00 a.m. to 6:00 p.m." Monday to Friday

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"East 24 th	West	from 108.2m south of Crockett to 6.4m southerly	Anytime"
------------------------	------	--	----------


and by adding to Section "E" thereof the following item, namely:

"Mars	South	Cheever to 11.7m easterly	Anytime"
-------	-------	---------------------------	----------

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

6. This By-law shall come into force and take effect on the date of its passing and enactment.
