CITY OF HAMILTON

BY-LAW NO. 10-083

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Brucedale North Upper James to 24m westerly 30min \$1.00"

and by adding to Section "E" thereof the following item, namely:

"Brucedale North Upper James to 24m westerly 1 hr \$1.00"

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"East 34th Both Crockett to Munn 2 hr 8am – 5pm Mon-Fri"

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Augusta	South	from 12.2m east of James to 6.1m easterly	Anytime
Chedmac	North & East	Rice to Redfern	Anytime
Chedmac	West	Redfern to Hepburn	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Chedmac	North & East	Rice to northerly end	Anytime"

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

9. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Braeheid	West	from 137.4m south of the extended south curb line of Rockhaven to 41.6m southerly	8:00 a.m. to 4:30 p.m." Monday to Friday September to June


