## **CITY OF HAMILTON**

### **BY-LAW NO. 11-019**

#### **To Authorize the Request for Extensions for Infrastructure Stimulus Fund Projects.**

**WHEREAS** the federal and provincial governments are providing a one-time extension of the deadline for funding of projects under the Infrastructure Stimulus Fund from March 31, 2011 to October 31, 2011;

**AND WHEREAS** all funding from the Government of Canada and Ontario will cease after October 31, 2011;

**AND WHEREAS** the City Of Hamilton has asked the provincial government for an extension to federal and provincial funding to October 31, 2011 for the following projects:

**THEREFORE BE IT RESOLVED THAT** the City Of Hamilton attests that it will continue to contribute its share of the required funding for the aforementioned projects;


**AND BE IT FURTHER RESOLVED THAT** actual claims for all eligible costs incurred by March 31, 2011, for the aforementioned projects must be and will be submitted no later than April 30, 2011;


**AND BE IT FURTHER RESOLVED THAT** City Of Hamilton will ensure that the project will be completed.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. This bylaw shall come into effect upon its passing.
3. This bylaw may be cited for all purposes as "City of Hamilton Request for Extensions for Infrastructure Stimulus Fund Projects Bylaw 11-019."
