CITY OF HAMILTON

BY-LAW NO. 11-076

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Arcade	Both	Gateview to Inverness	3 hr	8 am – 4 pm	Mon – Fri"
---------	------	--------------------------	------	-------------	------------

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following item, namely:

"Cross	West	Park to 44m northerly	Anytime"
--------	------	-----------------------	----------

and by deleting from Section "E" thereof the following item, namely:

"Hunter	North	commencing at Locke at extending 87 feet westerly therefrom	Anytime"
---------	-------	---	----------

and by adding to Section "E" thereof the following items, namely:

"Hunter	North	Locke to 33.1m westerly	Anytime
---------	-------	-------------------------	---------

Longwood	East	from 47m north of the extended north curb line of Marion to 25m northerly	Anytime"
----------	------	---	----------

and by adding to Section "F" thereof the following items, namely:

"Commerce	Both	Seaman to southerly end	Anytime
Seaman	Both	Dewitt to South Service	Anytime
South Service	Both	Dewitt to Fruitland	Anytime"


3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Fairfield	East	from 44m south of Vansitmart to 6m southerly	Anytime
Glendale	East	from 37.3m north of Cannon to 6.2m northerly	Anytime
Glendale	East	from 52.4m north of Cannon to 5.2m northerly	Anytime"


4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

5. This By-law shall come into force and take effect on the date of its passing and enactment.
