## **CITY OF HAMILTON**

### **BY-LAW NO. 11-087**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Ferguson	East	from 12.8m south of Barton to 145.4m southerly	2 hr	Anytime	Anyday
Ferguson	East	from 92.4m north of Cannon to 45.1m northerly	2 hr	8 am – 11 pm	Anyday
Frid	West	from 78.7m north of Chatham to 53.5m northerly	2hr	5:00 p.m. to 1:00 a.m.	Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


and by adding to Section "E" thereof the following item, namely:

"MacNab                      East                      from 56.5m south of Cannon                      Anytime"  
to 11m southerly

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

7. This By-law shall come into force and take effect on the date of its passing and enactment.
