## **CITY OF HAMILTON**

### **BY-LAW NO. 11-102**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Charles	West	Bold to Hurst	2 hr	8a m – 5 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Dicenzo	South	from 104.3m northerly and easterly of Genoa to 6m easterly	Anytime

Genoa	South	from 25.7m east of Dicenzo to 12.1m easterly	Anytime

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Chestnut	East	from 38.7m north of Cannon to 6m northerly	Anytime

Garfield	West	from 12.8m south of the north end of Garfield to 7.6m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Fairfield	West	from 90.4m north of Vansitmart to 6m northerly	Anytime

Garfield	West	from 13.9m south of the northerly end of Garfield to 6.4m southerly	Anytime"

4. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Glenholme	East	from 14.5m north of Glenholme to 41.5m northerly	Anytime"
------------	------	--------------------------------------------------	----------

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

6. This By-law shall come into force and take effect on the date of its passing and enactment.
