CITY OF HAMILTON

BY-LAW NO. 11-229

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"West 2 nd	East	Queensdale to Brantdale	1 hr	8 am – 5 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Central	North	From 50 ft. west of Summerhill to 50 ft. east of Summerhill	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Central	North	from 16.1m west of the extended west curb line of Summerhill to 54.6m easterly	Anytime

and by adding to Section "F" thereof the following items, namely:

"Baseline	North	from 14.1m west of East to 6m westerly	Anytime

and by adding to Section "G" (Loading Zones) thereof the following items, namely:

"Locke	West	from 39.7m south of Melbourne to 28.1m southerly	8:00 a.m. to 10:00 a.m.
Locke	East	Tuckett to 9.8m northerly	8:00 a.m. to 10:00 a.m."

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Newlands	North	from 22.9m west of Hope to 5.7m westerly	Anytime
Picton	South	James to Hughson	Anytime
Shaw	North	from 102.2m east of Victoria to 5.8m easterly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Justine	South	from 11.4m west of London to 6m westerly	Anytime
MacNab	East	from 26.1m north of Mulberry to 10.5m northerly	Anytime
Newlands	North	from 22.9m west of Cope to 5.7m westerly	Anytime
Niagara	East	from 75.9m north of Munroe to 6m northerly	Anytime
Picton	South	from 41.1m east of James to Hughson	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Dickenson Both from 355m west of Nebo to Anytime"
153m westerly


5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Glen South from 47.6m east of Paradise to 8:00 a.m. to 5:00 p.m."
4.7m easterly Monday to Friday


