

## CITY OF HAMILTON

### BY-LAW NO. 12-026

#### To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Morgante	South	from 28.8m east of Bianca to 7.8m easterly	Anytime"

and by deleting from Section "F" thereof the following item, namely:

"Highgate Drive	North	From Pinewoods Drive to point 58m west	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Dunn      West      from 41m south of Glow to  
7.6m southerly      9:00 a.m. to 6:00 p.m."  
Monday to Friday

5. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"East 26<sup>th</sup>      East      49 feet      284 feet north of  
Queensdale      7:00 a.m. – 6:00 p.m."  
Monday to Friday

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

7. This By-law shall come into force and take effect on the date of its passing and enactment.
