## **CITY OF HAMILTON**

### **BY-LAW NO. 14-152**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 4 (Special Event Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Rothsay Avenue	Lawrence Road to Maple Avenue
Kensington Avenue	Lawrence Road to King Street

Maple Avenue	Rothsay Avenue to Rosslyn Avenue

Rosslyn Avenue South	Maple Avenue to Justine Avenue	East	West
Maple Avenue	Rothsay Avenue to Balmoral Avenue South	South	North

Sherbrooke Street	Westerly End to Ottawa Street South	North	South
Afton	Lorne to easterly end	South	North
Balsam Avenue South	Maplewood Avenue to Afton Avenue	East	West"

and by adding to Section "E" thereof the following items, namely:

4. Sections 1 through 3 of this By-Law shall come into force and take effect at 5:00 a.m. on the 28<sup>th</sup> day of June, 2014, and shall be repealed and no longer in force and effect at 1:00 a.m. on the 2<sup>nd</sup> day of July, 2014.

“Main South from 21.3m east of Catharine Anytime”  
to 9m easterly

11. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

12. Sections 5 through 10 of this By-law shall come into force and take effect on the date of its passing and enactment.
