CITY OF HAMILTON

BY-LAW NO. 14-247

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 3 (Flashing School Zones- Reduced Speed Limit) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Cannon St.	Rosslyn Ave. to 50m east of East Bend Ave.	40	8:30 am to 9:00 am 11:45 am to 12:45 pm 3:30 pm to 3:45 pm
Cannon St.	Connaught Ave. to 110m west of Lottridge St.	40	8:20 am to 8:50 am 2:40 pm to 2:55 pm"

And by adding to Section "G" (Former Regional Roads) thereof the following item namely:

"Tapelytown Rd.	150m east of 3 rd E. to Tapelytown Rd.	50	8:20 am to 9:10 am 3:30 pm to 3:45 pm"

2. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Edgemont St. S.	King St.	Central Ave.	40km/h
Central Ave.	Edgemont St	London St.	40km/h"

3. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

"Burlington St.	275m east of Strathearne Ave. to 570m east of Strathearne Ave.	Anytime	Easterly to Northerly and Westerly to Southerly
Burlington St.	45m east of Hobson St. to 140m east of Hobson St..	Anytime	Easterly to Northerly and Westerly to Southerly"


4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

5. This By-law shall come into force and take effect on the date of its passing and enactment.
