CITY OF HAMILTON

BY-LAW NO. 14-251

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 4 (Yield Sign Locations) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "A" (Ancaster) thereof the following items, namely:

"Iroquois Avenue and Cayuga Avenue	On Cayuga Avenue	Iroquois Avenue
Seneca Drive and Iroquois Avenue	On Iroquois Avenue	Seneca Drive"

And by removing from Section "F" (Stoney Creek) thereof the following item,
namely;

"Red Oak Avenue	West	Deerhurst Road"

2. Schedule 5 (Stop Control) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following items, namely:

"Alterra Blvd.	Northbound	Charterhouse Cres.
Cayuga Ave.	Southbound	Iroquois Ave.
Iroquois Ave.	Eastbound	Seneca Dr.
Tomahawk Cres.	Northbound	Tuscarora Dr."

And by adding to Section "C" (Flamborough) thereof the following items, namely;

"Boulding Ave.	Northbound/Southbound	Laurendale Ave.
Hollybush Dr.	Northbound/Southbound	Chatsworth Cres./ Longyear Dr.
Laurendale Ave.	Eastbound/Westbound	Boulding Ave.
Howard St.	Northbound/Southbound	Liberty St."

And by removing from Section "E" (Hamilton) thereof the following items, namely;

"Markland St.	Westbound	Hess St.
Rebecca	Westbound	Ferguson
Rebecca	Westbound	Mary"

And by adding to Section "E" (Hamilton) thereof the following items, namely;

"Davinci Blvd.	Northbound/Southbound	Upper Paradise Rd.
Hughson St.	Northbound/Southbound	Forest Ave.
Markland St.	Eastbound/Westbound	Hess St.
Park St. S	Southbound	Robinson St.
