BY-LAW NO. 02-045

To Amend:

By-law No. 01-215

TO REGULATE TRAFFIC

WHEREAS Section 210(123) of the Municipal Act, R.S.O. 1990, Chapter M.45, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the Highway Traffic Act;

AND WHEREAS Section 314(7) of the Municipal Act confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 32 (Bus Stops) of By-law No. 01-215 is hereby amended by deleting from the "Inbound" column of Section "E" thereof the following item, namely:

"Magnolia opposite Minstrel (M/B)"

and by adding to said "Inbound" column of Section "E" thereof the following item, namely:

"Magnolia East 5.0m south of the south curb line of Vanessa Court,
near side (Northbound)"

and by deleting from Section "G" thereof the following items, namely:

"Queenston Road Rosewood Avenue NS I 110

2. Subject to the amendment made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

3. This By-law shall come into force and take effect on the date of its passing and enactment.
