**THE REGIONAL MUNICIPALITY OF HAMILTON-WENTWORTH**

**BY-LAW R99- 060**

**BEING A BY-LAW TO AMEND THE REGIONAL WATERWORKS  
BY-LAW R84-026, AS AMENDED**


WHEREAS the Council of The Regional Municipality of Hamilton-Wentworth on the 16<sup>th</sup> day of March, 1999, did approve Item 18 of Report 4-99 of the Environmental Services Committee which authorized the Phase-In of 1999 Non-Metered Water and Sewer Rates to come into force and take effect January 1, 1999.


AND WHEREAS the Council of The Regional Municipality of Hamilton-Wentworth on the 16<sup>th</sup> day of March, 1999 also authorized that the appropriate Regional By-laws be changed to reflect the Phase-In of 1999 Non-Metered Water and Sewer Rates.

NOW THEREFORE THE COUNCIL OF THE REGIONAL MUNICIPALITY OF HAMILTON-WENTWORTH ENACTS AS FOLLOWS:

1. That Schedule "A" to The Regional Waterworks By-law R84-026, as amended, is hereby repealed and Schedule "A" attached to this By-law be substituted therefor.
2. That Schedule "B" to The Regional Waterworks By-law R84-026, as amended, is hereby repealed and Schedule "B" attached to this By-law be substituted therefor.
3. That this By-law shall be deemed to have come into force and take effect as of January 1, 1999.
